Changes from Version 1 Draft

- Voting committee has to a representative from HRI but does not have to be associated with a TCMHCC program
- Added a non-profit organization member
- Clarified data review process and reduced time of Form 1 review (to assess feasibility) from 30 to 15-days and Form 2 review (detailed data request) from 45 to 30-days
- Clarified NECMHR instances when a review is not needed (when data is not associated with TCMHCC)
- Clarified that the 2-research networks (YDSRN and CTRN) reviews are not handled by the DDPC
- Clarified purpose of communication review
- Included need for acknowledgement on publications, including Corporate Authorship for publications directed by TCMHCC
